Wooden steps, steep slopes, grassy slopes in work areas.	Slips, trips and falls	Volunteers	Med	Work to be stopped if raining heavily or ground very wet or icy. Briefing to anyone not familiar with the site, check footwear is suitable for task/area of work. Verbal warnings not to try and reach litter or saplings where volunteer is not confident of their footing. In darkness all volunteers to carry torches. Dogs not on leads	May distract tool users, cause a fall or bite volunteers.	Volunteers	Low	Dog owners to be asked to control dog and to take it away from work area.	Susan Acton-Campbell and other competent persons
Bramble, hawthorn, blackthorn and gorse in work areas	Cuts/scratches	Volunteers	Med	Publicity recommends long sleeves to be worn Gloves provided. Volunteers to be advised to cover cuts and wounds, plasters available in 1st Aid kit. Advice to be given to thoroughly wash scratches on return home.	Susan Acton-Campbell and other competent persons

				Verbal warning to be given about tetanus risk especially with blackthorn	
Falling branches	Injury if hit	Volunteers	Med	In woodland check for loose hanging branches above work area and do not work in areas at risk from these falling.	Susan Acton-Campbell and other competent persons
Working in a public area	Public entering work area may be at risk from cut material, slips trips and falls	Public	Low	Use of signage or barriers is impracticable - volunteers will be asked to keep a look out for members of the public entering the area and take them to a safe area. Paths will be kept clear.	Susan Acton-Campbell and other competent persons
